- Maintaining septic systems regularly;
- Adhering to New York State Boating Guidelines for everyone's safety;
- Checking motorized vehicle engines for leaks seasonally;
- Using only non-phosphorous fertilizers;
- · Being aware of swim area boundaries;
- · Driving, biking, jogging, and walking with care;
- Bagging your leaves and lawn trimmings (Outdoor burning during specified dates---always call in your controlled burns);
- Spotting and removing invasive aquatic plant species;
- Protecting the erosion of our shoreline and its habitat with plantings;
- Respecting each other at all times!

All we need is LOVE... and our LAKE... May each of you have unlimited enjoyment, peace, and good health this spring and summer season.


## 2020 Annual July 4th Copake Lake Boat Parade



# 2020 Copake Lake Boating Rules And Regulations

Source, New York State Office of Parks Recreation & Historical Preservation (www.nysparks.com/recreation/boating)

**AGE:** Motorized boat operators must be 18 or over. Or, between the ages of 10 and 18 must have completed certified boating safety (NYS Law).

**AGE:** As of May 1, 2014, operators born after May 1, 1996 must have a NYS approved Safe Boating Course and be at least 10 years of age in order to operate a motorboat in New York State.

**BOATING HOURS:** Watercraft must not exceed 6 mph between 8 p.m. and 9 a.m. (Town Ordinance).

**NOISE:** All watercraft must have effective mufflers (Town Ordinance). Watercraft noise must not exceed 75 decibels (NYS Law).

**SPEED:** All watercraft must slow down to 5 mph when less than 100 ft from shore, dock, or other vessel, or in "no wake" zones (NYS Law).

RIGHT OF WAY: Motorized watercraft must yield to swimmers and non-motorized watercraft (NYS Law).

#### **SAFETY:**

- a. Personal Flotation Devices (PFD): Children under the age of 12 must wear approved PFD while in a watercraft. Approved flotation devices are required for each person on board (NYS Law).
- b. Water Skiing: Water skiers must have a "look-out" over the age of 10 (NYS Law).
- c. BWI: Boating while impaired or intoxicated subject to fines or imprisonment (NYS Law).
- d. Fire extinguisher, distress signal and anchor are required on ALL motorized watercraft.

#### PERSONAL WATER CRAFT (NYS Law):

- a. Operators must wear an approved PFD.
- b. Operator must be attached with a cut-off device.
- c. Can only be operated between sunrise and sundown and the town ordinance speed limit on the lake is less than 6 mph between 8:00 p.m. and 9:00 a.m. for any motorized vessel.
- d. May not be operated within 500 ft of a designated swimming area.
- e. Reckless operation prohibited (wake jumping, weaving through traffic, or other maneuvers that jeopardize safety).

**REGISTRATION:** All motorized watercraft must be registered and display the registration numbers (NYS Law).

#### **ENVIRONMENT:**

- a. Help keep unwanted aquatic plants and zebra mussels out of the lake. Thoroughly wash your vessel and flush the cooling system at a location away from the shoreline.
- b. Avoid spilling gasoline or oil. Repair leaks immediately.
- c. Dispose of litter properly in bins on shore.
- d. Do not use soaps or cleansers in or near the lake.

Common sense and respect for others are the way to ensure a safe and enjoyable experience for everyone using the lake. CLCS is not

a law-enforcement agency and leaves such duties to the Columbia County Sheriff's Department, The CLCS has posted rules and regulations and distributes these excerpts to encourage lake users to know the rules and observe them.

Concerns about speed, noise, or safe handling of any motorized watercraft on the lake should be directed to: COLUMBIA COUNTY SHERIFF'S DEPARTMENT 518-828-3344.

# NYS Rules and Regulations for Non-Motorized Watercraft (Kayaks, Paddleboards, etc.)

ersonal Flotation Devices (PFDs) must be worn year-round by all children under 12 years of age on any boat less than 65 feet in length, unless within a fully enclosed cabin; by anyone engaging in towed activities, such as water-skiers or wake-boarders; and while on board a personal watercraft. Otherwise, a wearable life jacket must be available for every passenger on board every vessel, including non-motorized watercraft such as canoes and kayaks." New York State Boating Laws and Regulations, 2010, see <a href="https://www.nysparks.com/recreation/boating">www.nysparks.com/recreation/boating</a>.

Along with rowboats, kayaks, canoes, and sailboats, paddle boards are considered boats and must have a U.S. Coast Guard approved, properly sized, serviceable, and readily accessible life jacket on board for each person, just like any other boat, mechanized or not. From May 2 through October 31 such persons are not required to wear a life jacket, though it is highly suggested (but they must have one on board and readily accessible).

From November I to May I, everyone on all pleasure vessels which include paddleboards, rowboats, kayaks, canoes, sailboats, and motorboats must be wearing a life jacket while underway, which means as long as the boat is not anchored

or tied to a dock. Drifting counts as underway.

Life jackets are the most important piece of equipment on a boat and can save your life; we recommend that they be worn at all times.

## ARE YOU AWARE OF THE NEW NYS BOATING LAW AS OF JANUARY 1, 2020?

new boating law, known as Brianna's Law, went into effect on January I, 2020. By January I, 2025, the new law requires ALL operators of ALL power boats, including electric motors, to take an approved NYS boating safety course. A 5-year phase-in period applies to all operators of all motorized watercraft, including electric motors.

Under this new law, the phase-in period for all motor boat operators will be as follows:

- Born on or after Jan. I, 1993 will need a boating safety certificate beginning in 2020.
- Born on or after Jan. I, 1988 will need a boating safety certificate beginning in 2022.
- Born on or after Jan. I, 1983 will need a boating safety certificate beginning in 2023.
- Born on or after Jan. I, 1978 will need a boating safety certificate beginning in 2024.
- All motor boat operators regardless of age will need a boating safety certificate beginning on January 1, 2025.

Fines of between \$100 and \$250 will be imposed for failure to comply under the new law that took effect as of Jan. 1, 2020. The New York

State Office of Parks, Recreation and Historic Preservation, which administers the law, estimates that there are nearly one million boaters who will have to take the boating safety course before the completion of the phasing in on Jan. 1, 2025. Further information on this law and classes can be found on the following website: https://parks.ny.gov/recreation/boating/education.aspx.

As a reminder, Personal Floatation Devices (PFD's) are required to be worn by, and securely fastened to, any youth under the age of 12 on boats 65 feet or less in length (NYS Nav. Law Section 40.1(d)). PFD's are also required on every pleasure vessel including canoes, kayaks, paddle boards, and rowboats operated upon the waters of NYS. You must have on board one U.S. Coast Guard approved wearable PFD for each person on the watercraft. In addition, vessels 16 feet and greater in length must also carry a type IV throwable PFD.





Copake Lake Conservation Society (CLCS) Shoreline Clean-Up Day is scheduled for May 30, 2020 (Saturday following Memorial Day Weekend), with rain date of Sunday, May 31, 2020) from 9:00 a.m. to 12:00 noon. This event is sponsored by the Copake Lake Conservation Society for the express purpose of removing debris that has accumulated over the winter from Copake Lake and from its shoreline. Copake Lake neighbors are asked to remove debris from the lake and shoreline and place it along Golf Course Road, Lakeview Road, and County Rte. 7 up to Juliana/Jefferson Drives. # Lake Level on Copake Lake

opake Lake is a natural lake that is only fed by rainfall and the run off into the lake from rainfall. A small dam was installed in the early 1900s to maintain the level for ice making in the winter. The dam is owned and controlled by the Copake Country Club.

#### **Dam and Valve**

The owners of the Copake Country Club consult with the Copake Lake Conservation Society (CLCS) on the timing of the operation of the dam. The dam has a valve that is opened to draw down the level of the lake to avoid winter ice damage to the shoreline that causes erosion. The valve is opened in late fall to draw down the lake no more than 2 feet. The valve is closed in late winter to allow the lake to refill with spring rains.


#### **Lake Level**

During the spring/summer season with the valve closed, water flows over the spillway, thus fixing the lake level at maximum. In a wet summer, the lake level will stay constant, perhaps rising after heavy rainstorms. In a dry/hot summer, the lake level will slowly fall due to evaporation.

When Copake Lake receives treatment for nuisance weeds and/or algae, NYSDEC (New York State Department of Environmental Conservation) requires no water flow out of the lake. To hold the water in the lake, the lake level will be kept below the spillway before treatment.

So, once the nuisance weed/algae treatments are done in late spring, the level of the lake depends upon the weather. Please consult the CLCS website under FAQs for additional information (www.copakelakecs.org).

# 2019 Lake Management Committee Meeting Report Summary of 2019 & Action Plans for 2020

Attendees: Barb and Fred Bunger, Lindsay LeBrecht, Buddy Sinisi, Russ Stein, Keith Schaefer, Debra Ruggieri, AJ Reyes of NEAR. and Kara Sliwoski and Ben Casseles of Solitude.

Regrets: Ed Werfelman, Stu Troyetsky, Jed Luchow, Brad Dubler, and Mike Whitcomb

#### I. Health Monitoring

2019: All samples well under the level of concern. Swimmer's Itch reported in May and June, but there were no reports after early July.

2020: Kara suggested contacting Alpha Analytical in Albany to bid on the CLCS water testing. Stu will continue to sample the lake for coliform bacteria in late June, mid-July, and mid-August for potential sources of coliform contamination.

2020 Budget \$1,500

#### 2. Shoreline erosion:

2019: Barb reported that coir logs installed in 2017 deteriorated quickly due to wave action. Stone added in February 2019 under NYS permit seem to provide good protection.

2020: NEAR to monitor shoreline erosion and report on problem areas.

2020 Budget: \$1000 for education and studies.

#### 3. Grant Program:

2019: One grant request approved by the Grant Committee, but turned-down by the LMC Trustees when it was determined that the work did not materially improve lake quality.

2020: Grant program suspended for 2020.

#### 4. Invasive Species Control:

2019: One visit by Captain Bob got several large carp.

2020: AJ to contact NYS Fisheries to determine if carp in Copake Lake are a serious concern. Lindsay to continue contact with Captain Bob.

2020 Budget: \$500 (until carp issue defined).

#### 5. Lake Level and Dam:

2019: Lake level was satisfactory for all lake users. Dam reclassified as minimum risk A class. Engineering to meet NYSDEC requirements for repair is in progress with Hans Hasnay or WSP Engineering. Changes to spillway to increase overflow rate and simplify lake drawdown and refill will be included in the design.

2020: Drawdown in November, refill to start as danger of ice on shoreline is past.

2020 Budget: \$10,000 if needed to complete dam repair and modification engineering. (We have not spent any of the 2019 budget yet. This should probably be \$10,000 just to cover the 2019 work. Plus at least \$10,000 for the actual work.)

#### 6. Invasive Weed Control:

2019: (See report from AJ Reyes of NEAR). We will be in the second year of our three-year contract with Solitude. Mid-May spot diquat controlled curly-leaf pondweed, but saw new growth in other areas of the lake. Native weeds abundant in August. A few spots of milfoil and brittle naiad seen in September.

2020: Third year of 3-year contract with Solitude. Four options for spot curly leaf control:

- #1. Diquat, (if NYSDEC removes 14 day restriction).
- #2. Flumoxycin, which has only a 5-day irrigation restriction, maybe added cost.
- #3. Aquathol, used before, with reasonable results.

May consider diver hand-pulling of the small milfoil areas.

#4. For future milfoil control, ProcellaCOR® EC was recently approved by NYSDEC. Procella® requires only a one-day permit and is approved for drinking water. Third year of Solitude contract is \$31,592 plus allocate \$10,000, if needed, for diver harvesting of late season nuisance weed control.

2020 Budget: \$41,492

#### 7. Algae and Clarity:

2019: Lake clarity ranged from 24 feet in June to 8 feet in early September. Schedule issues resulted in heavy filamentous algae late June to early July. July 10th treatment with SeClearG (copper sulfate pentahydrate) controlled the algae for the season. Bluegreen algae was not seen in high concentration in 2019.

2020: Secure permits for SeClear and/or copper sulfate as needed to control.

2020 Budget: included in Solitude contract.

#### 8. Stormwater and Sediment Control:

2019: Town worked on adding stone and gabions to some Bird Roads ditches.

# 2019 Lake Management Committee Meeting Report Summary of 2019 & Action Plans for 2020 (continued)

2020: CLCS will set aside \$10,000 to provide material for the Town of Copake, if needed to work on drainage.

2020 Budget: \$10,000

#### 9. Shoreline Cleanup

Cleanup will be moved to Saturday immediately following Memorial Day Weekend. Waste management companies will not deliver and/or pick up dumpster during the holiday weekend.

2020 Budget: \$600
